Dear Families:

The announcement, *"Due to severe weather conditions, the Wethersfield Public Schools will close early today"* can create a stressful situation for children and parents. I recognize such a decision presents difficulties for many families, particularly if parents are at work. This is a major consideration when a decision is made to close school early, and our Superintendent only makes this decision when all indicators suggest it is the safest alternative. **Our early dismissal time is always at 12:55 p.m. (12:45 p.m. for Kindergarten).**

In the event of an **Early Closing** for Wethersfield Public Schools, a Parent Square message will go out to families from the Superintendent and announcements will be broadcast on local radio and television stations. This information will be posted on the Wethersfield Public Schools website at <https://wps.wethersfield.me>. **Please do not contact the school** in this situation as we need to keep our school phone lines open and avoid an overabundance of calls to the system.

Therefore, I ask that you sit down today with your family to develop and review a **"Family Emergency School Closing Plan"** which might include the following:

- A. Listing several homes in the neighborhood to which your child can go in a specific order and reviewing the list with your child.
- B. Reminding your child to go to a designated neighbor's home and to leave a note (in the mailbox, the back door, etc.) as to where he/she has gone.
- C. Having your child go home to a friend's house as pre-arranged with the other child's parents.
- D. Showing your child where an extra key is kept.
- E. Please do not have your child call you from school as part of the plan, as we are not able to accommodate outgoing phone calls from students during an unscheduled early dismissal.

Thank you for your cooperation in completing the information on the attached form. Please return it to your child's classroom teacher by **Friday, September 6, 2024.**
